Ordinance 454 removing no. of cats allowed per premises:

AN ORDINANCE TO AMEND PROVISIONS RELATING TO CHAPTER THREE, ARTICLE THREE, SECTION 307: DOGS AND CATS; NUMBER ALLOWED; TO REMOVE CATS; REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT WITH THIS ORDINANCE; ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRPERSON AND BOARD OF TRUSTEES OF THE VILLAGE OF OXFORD, NEBRASKA:

Section 1. That Chapter 3, Article 3, Section 307 shall be amended to read as follows: Section 307: DOGS; NUMBER ALLOWED No residential or commercial property within the village limits shall keep, harbor or maintain more than three dogs per residence, over four months of age.

Section 2. That any other ordinances or sections passed and approved prior to this passage, approval, and publication or posting of this ordinance in conflict with its provisions, are hereby repealed.

Section 3. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law, and shall be published in pamphlet form.

Passed and approved this 16th day of March, 2020.

Trustee McQuiston introduced Ordinance 454 and asked that the three readings be suspended, seconded by Hamilton. Roll call. Voting in favor: Minarik, Hamilton, Cunningham, McQuiston and McInturf. Opposed: None. Motion carried.

Trustee Hamilton moved for final passage, seconded by Minarik. Roll call. Voting in favor: Cunningham, Minarik, Hamilton, McQuiston and McInturf. Opposed: none. Motion carried.

<u>Memorial Tree and Bench Program:</u> the board reviewed the draft pamphlet for the memorial tree and bench program. Pricing will be determined based on cast of products and installation. These are still being worked on. Locations for trees and species will be worked and on as well as locations for benches. Hoffman and Calderone will work on moving forward with the program.

<u>Information from Barb Knuth on cats:</u> Barb provided information relaying she will work on forming an independent non-profit for Oxford Community Cat Project. Currently they are concentrating on the area north of downtown and will trap and spay and neuter and return. This is a private group and is not affiliated with the city. Knuth did ask if some copies could be made at the Village office to pass out to residents. Village board agreed to allow for some use of the copy machine.

Oxford Jr. Shooters request for Keno Funds: Event was cancelled

<u>Clerks/Treasurer's Report</u>. Cleanup will still be March 24. Trustee Cunningham had expressed a need to find ways to positively boost Oxford. The Village is putting almost \$60,000.00 in the pool for renovations, painting lights, etc. Oxford Pool and Park committee has been donating playground

equipment to the North park. Scott Grosenbach has agreed to assist Clerk Calderone with verifying information in the cemetery book to how the ground and burials are recorded. Calderone hopes to have that information into the computer by the end of the year. Clerk School has been cancelled. The League has sent out emails with sites that the Village board can utilize to keep up with executive orders from the governor during this time of the coronavirus pandemic.
